Athletics North East will be running our next camp from the **25th until 27th October from 10am - 3pm** @ Gateshead College Academy for Sport for children aged 8 years and over.

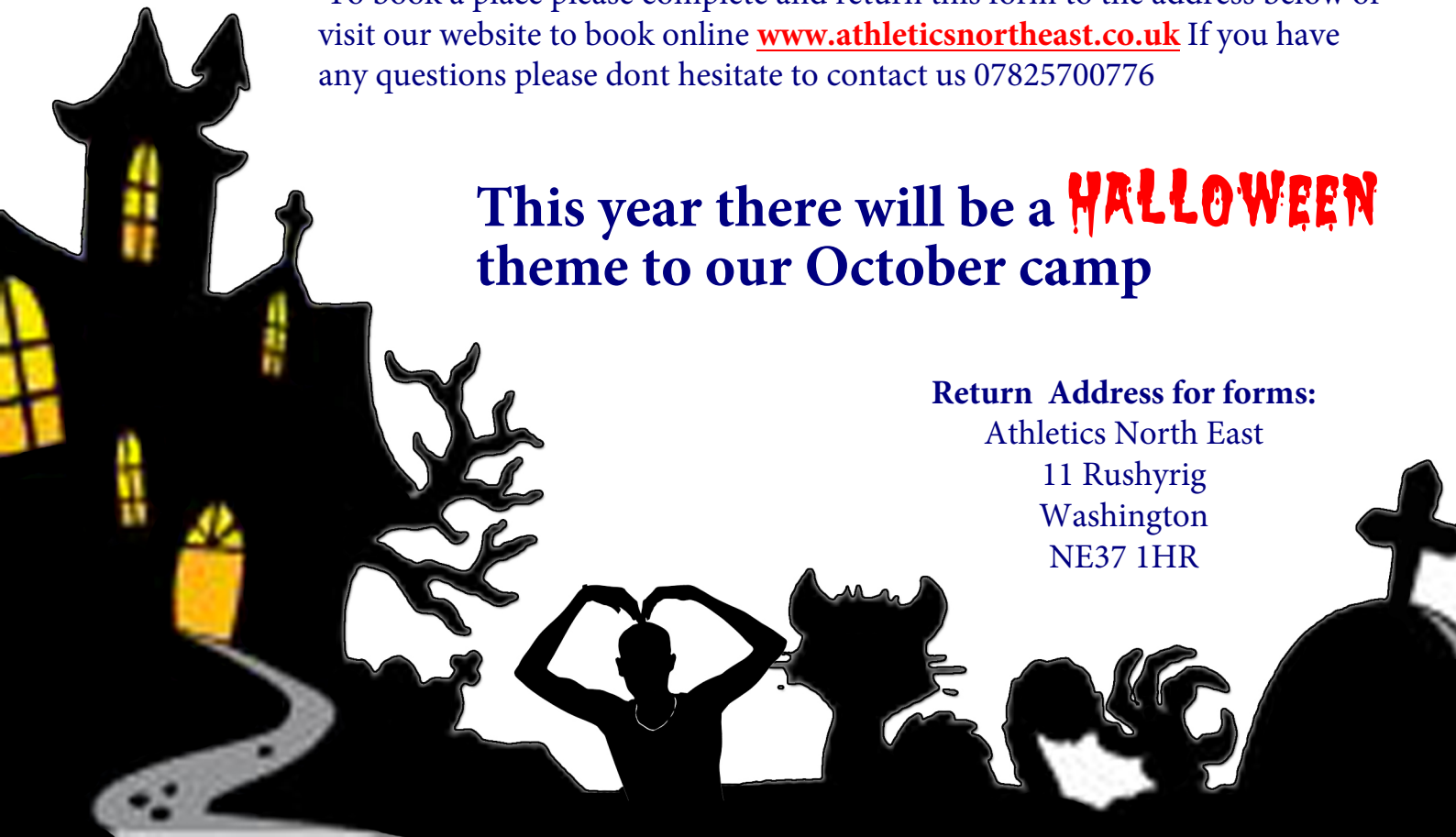
Our athletics camp will give your child/children the chance to try a wide variety of athletic events: pole vault, high jump, hurdles, javelin and much much more....
